



## ***REGAL PATIO DOOR TWENTY YEAR LIMITED WARRANTY***

Our Regal Patio Doors are warranted for a **TWENTY YEAR** period from the date of purchase, to be **FREE** of **DEFECTS** in **MATERIALS** and **WORKMANSHIP**. **MVP**, at its sole discretion will repair, replace, or refund the original purchase price of Regal Patio Door products, found to be defective. This warranty does not cover repairs or replacements due to **IMPROPER** installation or handling, abuse of the product, vandalism, accidents, or acts of God. For as long as the Original Purchaser/Present Property Owner shall **OWN** and **LIVE** in the property, the Regal Patio Door lineal vinyl extrusion itself, will be warranted against cracking, peeling, flaking, blistering, corroding, or **DISCOLORATION** which is unique to Regal Patio Door extrusions.

**MVP** warrants all insulated glass from obstruction of vision, as a result of dust or internal condensation formation between the glass surfaces, caused by the **FAILURE** of the insulating sealant for a **TWENTY YEAR PERIOD** from the date of manufacture as per the **PRORATED GLASS REPLACEMENT SCHEDULE**.

Regal Patio Door products are warranted to be free from stress cracks for **ONE YEAR** from the date of manufacture, however glass breakage or cracking resulting from accident, abusive handling, misuse, or shattering from heat buildup is not considered to be a product defect and is therefore not covered in this warranty.

### ***LIMITATIONS***

MVP shall have no liability for repair, replacement, or other compensation under this warranty for:

- a) Defects or failure caused by improper handling, storage, abuse, neglect, or improper installation.
- b) Any damage to the product caused by the impact of foreign objects, acts of God, fire, explosion, or other casualties.
- c) Defects caused by the effects of air pollution, exposure to harmful chemicals or normal weathering caused by exposure to the elements.
- d) Consequential or Incidental damages caused by the defect or failure of any Regal Patio Door warranted product, including, but not limited to, damage to materials or the occurrence of mold due to the windows by unauthorized persons.

Regal Patio Door screens are designed for insect exclusion, **NOT AS A CHILD RESTRAINT**. Therefore, this warranty does not include torn screening, or injuries resulting from children or pets falling through the screen.

Materials found to be defective will be repaired or replaced at the discretion of **MVP**. The maximum liability shall be equal to the purchase cost of the original window. Replacement windows or components will be shipped to the dealer from whom the original window was purchased, as it was originally supplied by **MVP**. Labor to install or paint replacement components is not covered or included in this warranty.

**MVP** reserves the right to make changes and improvements in its products over the years and when replacement components are necessary will provide the closest product available to the originally manufactured item.

**Claims shall include the nature of the problem, date of purchase, and invoice number or other proof of purchase.**
